#### Type of business:

This is an excellent opportunity to acquire a successful fully equipped event and mobile bar business. Established for more than 25 years this business is the main providor of event and mobile bar services in its area and often has advance bookings running to 30-40 events.

Working mainly at the weekends the business has between 1 - 3 events per week. It has very high levels of repeat custom providing drinks for parties, dinners, engagements, weddings and funerals together with music festivals and other events.

Fully equipped to provide a full bar service to upwards of 400 guests the business has its own generators, beer coolers, refridgeration, etc so can operate indpendently of any fixed facilities.

#### Financial information:

This business mainly trades one or three days per week and the owner maintains the turnover below the VAT threshold.

It is a highly profitable business with low overheads and stock mainly purchased as required.

The business has many repeat annual events and is the main provider of bar services to many local halls.

### Staffing:

The husband and wife owners run the business either on their own or with additional part-time staff as required for larger functions.

#### Premises:

While the business is fully mobile, relocateable and all the equipment could be stored in a space equivalent to a double garage, the current owners have a freehold shop unit they use for storage and ice making.
